

1. Risks of abseiling from the Euromast. The undersigned declares to be aware of the dangers associated with abseiling from the platforms of the Euromast at a height of 100 meters (the Activity). The Activity, organized by Abseilen.nl and Euromast Horeca B.V. (hereinafter jointly referred to as the Euromast), is inherently dangerous and carries the risk of (serious permanent) injury and death (the Risks). The undersigned is aware of the Risks and chooses to participate in the Activity voluntarily and entirely at their own risk.

2. Circumstances increasing the realization of the Risks. Under certain circumstances, the likelihood of realizing the Risks may (whether greatly or not) increase (Risk Increasing Circumstances or RICs). Such circumstances are generally beyond the control of the Euromast. Examples include (but are not limited to) the physical condition of the undersigned and/or failure to follow instructions from the Euromast. Another example is reckless behavior of the undersigned. The undersigned acknowledges that RICs can significantly increase the chance of (serious permanent) injury during the Activity.

3. The undersigned and the Risk Increasing Circumstances. Taking the above into account, and particularly considering the Risk Increasing Circumstances mentioned herein and hereafter, the undersigned declares: i) to be in good health (i.e., no medical conditions increasing the risk of injury), ii) to have consumed no alcohol, drugs, and/or medication, iii) to wear 'appropriate' shoes (i.e., no slippery soles), iv) to have emptied their pockets – except for the entrance ticket for the Activity, v) to tie back long hair in a ponytail or braid, and vi) to always follow the instructions of the Euromast (staff). The foregoing list is non-exhaustive. The undersigned is aware of this and acknowledges the Risks of the Activity.

4. Permission from the Euromast (and revocation thereof). In order to participate in the Activity, the undersigned must first obtain permission from the Euromast and related companies. The Euromast reserves the right to revoke permission granted to the undersigned and others without providing reasons. This may occur in cases of sudden onset of fear, reckless behavior, etc. Communication during the Activity will take place in Dutch or English. If the Undersigned does not have sufficient command of either language, participation is only permitted if a translator accompanies them during the Activity. A valid reservation for the translator must be made separately and for the same time slot. If the Undersigned is unable to communicate in Dutch or English and no translator has been reserved for the same time slot, participation in the Activity will not be permitted. Access to the Activity will then be denied: the undersigned(s) will not descend from the Euromast. If access to the Activity is denied to the undersigned, they agree that no refund will be granted.

5. Waiver and/or limitation of liability. Participation in the Activity is entirely at the undersigned's own risk. The Euromast never accepts (contractual and/or legal) liability for injury and/or property damage (Damage) to the undersigned (and/or third parties), unless prohibited by law. This is especially true for Damage to the undersigned (and/or third parties) resulting from one or more of the RICs and/or the undersigned's statement in this regard. The undersigned acknowledges that Damage resulting from one or more of the RICs can only be attributed to themselves. Liability for indirect and consequential damage is excluded under all circumstances, except in cases of intent or gross negligence by the Euromast. In any case, the Euromast is never liable for uninsured damage and neither is it liable for more than the amount covered by its insurance.

- In case of absence at the agreed abseiling time, there will be no refund or alternative time available;
- The same applies in case of refusal by the participant (e.g., due to sudden onset of fear, etc.);
- The participant is aware that taking photos/filming within the restricted area for safety reasons is prohibited. If the participant does so, access to the Activity will be immediately or subsequently denied;
- Furthermore, the participant grants permission to take photos and publish them on the website www.nabestellen.nl. The photos will remain public until 1 month after the end of the event;
- The Euromast and Abseilen.nl reserves the right to take photos and/or recordings before, during and/or after the Activities and to use them for its own promotional purposes;
- Acknowledged to be aware of the general conditions.
